

# Terms and Conditions of the MIRASCON gift card campaign 2022

## 1. Subject matter of the Conditions of Participation and Organizer

(1) These conditions of participation regulate the conditions for participation in our (MIRASCON Versicherungsagentur GmbH aka "MIRASCON Insurance Agency") Amazon.de<sup>1</sup> gift card campaign and for any transfers of rights where necessary.

(2) The organizer of the campaign is MIRASCON Versicherungsagentur GmbH, Amsterdamer Str. 206, 50735 Cologne, Germany, herein after called MIRASCON.

(3) By participating in this campaign these terms and conditions are accepted.

(4) The campaign is under no circumstances affiliated with suppliers of prizes, nor is it sponsored, organized, or financed by any third party.

## 2. Participation

(1) All individuals who are over the age of 18 are eligible to enter the campaign, if they are in possession of a valid ID card, and are stationed in Germany under the SOFA Agreement or residing as an Expat in Germany. Excluded from the campaign are employees of MIRASCON, as well as employees of affiliated companies and relatives of such employees. Participation under an assumed identity or third-party identity is not permitted.

(2) The entry rules for the giveaway are as follows:

- Every customer of MIRASCON with a signed new vehicle insurance policy in Germany is entitled to enter, if the signed date on the contract is in the current month or the following month\*.

(3) Each eligible customer is allowed to participate only once per contract during the duration of the campaign until December 31<sup>st</sup>, 2022.

(4) The campaign runs from January 10<sup>th</sup> to December 31<sup>st</sup>, 2022.

*\*Example: If the signed date is April 1<sup>st</sup>, you can enter for the giveaway by May 31<sup>st</sup>. If the contract is signed April 30<sup>th</sup>, you can enter for the giveaway by May 31<sup>st</sup> at the latest. Contracts that are signed in December 2022 can only participate by December 31<sup>st</sup>, 2022 since this is the cutoff date of the campaign.*

## 3. Winnings and win notification

(1) Among all eligible participants the giveaway consists of an Amazon.de<sup>1</sup> gift card, valued at 50 EUR.

(2) The winner drawing is once per month until the 10<sup>th</sup> of the following month. The winner will be randomly selected among all eligible participants. The last drawing for the campaign is January 10<sup>th</sup>, 2023.

(3) MIRASCON is allowed to announce the monthly winner on the company's Website and Social Media pages (such as Facebook or Instagram) or by any other means at MIRASCON's discretion.

(4) In order to receive the prize, the winner needs to reply to the winning notification email which will be sent to the entitled participant after the winner drawing. This is for validation of the email address to send the gift card via email (e-gift card). If no email is received from a winner within 7 days from the time of the notification, the winner's entitlement expires. In this case, MIRASCON will carry out a new drawing.

(5) If circumstances arise beyond the organizer's control, the winner of the respective drawing accepts a reasonable replacement of the prize.

(6) MIRASCON will send the prize directly to the winner's provided email address. We are not responsible for delivery failure. MIRASCON may choose to transfer the prize either in person or by any other means as per MIRASCON's discretion.

(7) If the prize will not be transferred by email, a physical mailing delivery of the prize is only available to an address inside Germany. This could also be an APO address of a military installation in Germany. By transferring the prize to a carrier, the risk of loss passes to the winner. We are not responsible for delivery damages or failure.

(8) If there is no entitled winner, MIRASCON reserves the right to dispose of the prize in any manner necessary.

### 5. Liability and Waiver

By participating in the campaign, the participant releases MIRASCON from all and any liabilities.

### 4. Exclusion

A violation of these conditions of participation entitles us to exclude the respective participant from participation.

### 5. Early termination and changes

MIRASCON reserves the right to terminate in full or in part or modify the giveaway at any time. Reasons might be technical (e.g. computer virus, manipulation of or errors in software / hardware) or legal (e.g. prohibition by Amazon.de<sup>1</sup>), or if a proper performance of the giveaway is no longer possible.

### 6. Privacy

### 7. Final provisions

(1) If the conditions of participation contain ineffective regulations, the validity of the remaining conditions remains unaffected.
